### APPLICATION RATES AND TIMING

CROP	RATE	TIMING	WATER L/ha
All beans	600ml-1L/ha	Apply when plants at 4 leaf stage. Repeat as advised	250
Potatoes	600ml-2.5L/ha	Apply 2-3 weeks after emergence. Repeat at 7 weeks	250
Vegetables	600ml-1L/ha	Apply 5-10 days after transplanting. 10-14 days after emergence if seeded crop. Repeat as advised.	250
Cucurbits, Melons, Cucumbers	600ml-1L/ha	Apply at flowering	250
Tomatoes	600ml-1L/ha	Apply 5-10 days after transplanting. Repeat application every 4 weeks.	250
Barley, Canola, Lucerne, Oats, Sorghum, Wheat	600ml-2.5L/ha	Apply when plants are young as this is a critical time. Repeat as advised.	50
Citrus and Vines	1.5-2.5L/ha	Apply 2 weeks after bloom. Repeat as advised.	1000
Stone fruits, Pome fruits	1-2L/ha	Apply 2 weeks after bloom. Repeat as advised.	1000
Strawberries & All berries	600ml-1L/ha	Apply 5-7 days after transplanting	250
Ornamentals & Flowers	600ml-1L/ha	Apply every month. Do not apply on Chry santhemums	250
Pasture	1-2.5L/ha	Apply when Copper deficiency occurs.	500

### GENERAL INSTRUCTIONS

#### MIXING AND SPRAYING

Shake the container thoroughly before use. Pour through the filter into the tank three quarters filled with water, whilst agitating. Top up with water and continue to agitate until spraying is completed.

#### PRECAUTIONS

Avoid application under extremes of climate eg. Rapid drying conditions, extremely slow drying conditions, frost rain or when frost or rain are anticipated

#### COMPATIBILITY

RUTEC products are widely compatible with many agrichemicals. Contact your distributor for information.

#### STORAGE AND DISPOSAL

Store in the closed original container, in a well-ventilated area as cool as possible. Protect from frost. Do not store for prolonged periods in direct sunlight.

Triple rinse containers before disposal and add hoses to tank mix or dispose of rinsate in a disposal pit away from desirable plants, their roots and watercourses.

On-site disposal of undiluted chemicals is unacceptable. Destroy empty containers by breaking, crushing or puncturing them. Dispose of the containers at a local authority landfill that does not burn its refuse. If there is no local authority landfill readily available in your area, bury the containers to a depth of 500mm or more at a licenced/approved disposal site. In some states wastes can only be buried at a licenced landfill. Do not burn empty containers or product.

#### SPILLAGE

Hose small spillage (less than 1 litre of concentrate) away with a large excess of water. Large spillage should not be directed to drains. Large spillage should be absorbed in sawdust or sand and the absorbent material containing the product disposed of in a sealed container at an approved disposal site.
