GENERAL

RUTEC Zn 740 is specifically formulated to use on crops known to suffer from zinc disorders eg. kale, canola, maize, blackberries, raspberries, kiwi fruit, avocados, tomatoes, bananas, onions, sunflower, cotton, citrus, sorghum, potatoes, cereal crops and beans.

RUTEC Zn 740 is an excellent zinc source to aid in the correction of zinc deficiency.

RUTEC Zn 740 is suitable for soil and/or foliar application.

When foliar application is desirable **RUTEC Zn 740** should be applied as a 0.1% solution or less (250ml-250L). To obtain maximum benefit, foliar applications should be started as early as possible in the season, as soon as there is sufficient leaf area to intercept the spray. In the case of severe deficiency, applications may be repeated at weekly intervals.

Spraying should be carried out on a calm day, but not during strong sunshine. The best time is late afternoon or evening, when atmospheric humidity is greatest.

APPLICATION RATES

Soil Application-

Fruit (trees, bushes) - large trees 60-200ml/tree, small bushes - 4-16ml/bush
Field Crops - 1-2L/ha

Foliar application -

Fruit Trees - 500ml-2L/ha. Further applications may be necessary during the course of the season.

Field Crops - 500ml-1L/ha

Irrigation - One or more Rutech chelates can be injected into the system at the rate of 2L/10,000 Litres until appropriate rate/ha has been attained.

GENERAL INSTRUCTIONS

Rutec Zn 740 can be applied as a high volume or low volume spray or direct to the soil and is suitable for application by aircraft

MIXING; Fill spray tank with water then pour the recommended amount of RUTEC Zn 740 on top of the water with the agitator running. Combination sprays- mix all products as recommended, fill spray tank with water, then pour Zn 740 in last with agitator running.

COMPATIBILITY;RUTEC Zn 740 is compatible with most insecticides, fungicides and herbicides. If RUTEC Zn 740 is being applied in combination, check label "Recommendations for Compatibility". If in doubt mix a small amount in a glass tumbler and observe.

STORAGE AND DISPOSAL

Store in the closed original container, in a well-ventilated area as cool as possible. Protect from frost. Do not store for prolonged periods in direct sunlight.

Triple rinse containers before disposal and add hoses to tank mix or dispose of rinsate in a disposal pit away from desirable plants, their roots and watercourses.

On-site disposal of undiluted chemicals is unacceptable. Destroy empty containers by breaking, crushing or puncturing them.

Dispose of the containers at a local authority landfill that does not burn its refuse. If there is no local authority landfill readily available in your area, bury the containers to a depth of 500mm or more at a licenced/approved disposal site. In some states wastes can only be buried at a licenced landfill. Do not burn empty containers or product.

SPILLAGE

Hose small spillage (less than 1 litre of concentrate) away with a large excess of water. Large spillage should not be directed to drains. Large spillage should be absorbed in sawdust or sand and the absorbent material containing the product disposed of in a sealed container at an approved disposal site.

PROTECTION OF WILDLIFE, FISH, CRUSTACEA AND ENVIRONMENT

Do NOT contaminate streams, rivers or waterways with the chemical or used containers.

SAFETY DIRECTIONS
